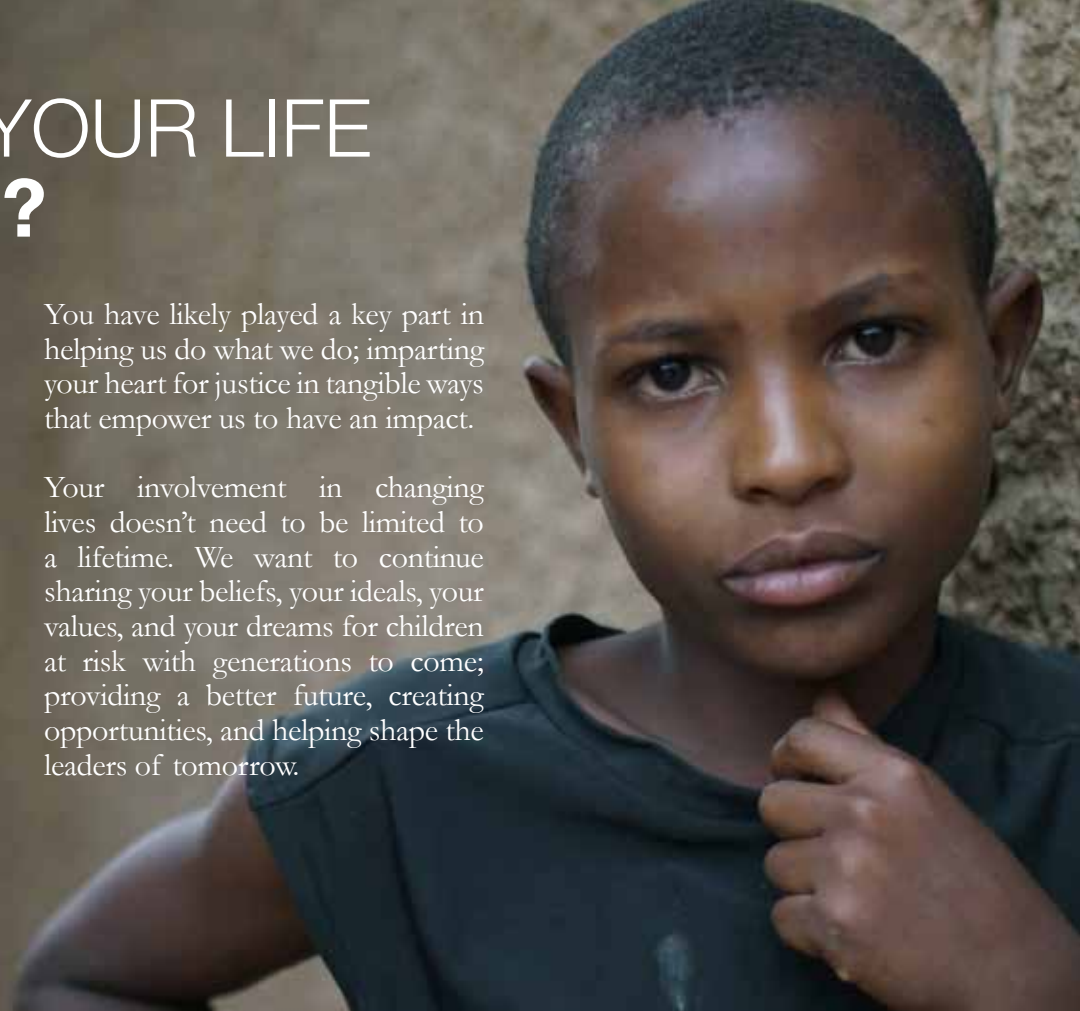
WHAT WILL YOUR LIFE STAND FOR?
